1. Introduction

- Organization of national and international seminars, workshops, and conferences.
- Collaboration on research projects, publications, and scholarly initiatives.
- Undertaking any additional activities that contribute to strengthening academic cooperation between the institutions.

4. Implementation

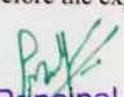

5. Duration and Renewal

This MoU shall remain in force for a period of five (5) years from the date of signing. It shall be automatically renewed for a subsequent term of five years unless either institution provides a written notice of intent to terminate the agreement at least six (6) months before the expiry date.
