- Maintain discipline, attendance and progress records during training.
- Provide necessary coordination and communication with the Industry Partner.
- Facilitate smooth conduct of workshops and awareness sessions within the campus.

Responsibilities of Vipul Industries, Risia Bahraich

The Industry Partner agrees to:

- Provide internship, on-site training and practical industrial exposure to students.
- Offer professional guidance on manufacturing processes, quality control and work culture.
- Consider eligible students for placement opportunities as per requirement.
- Support the Institution in designing industry-aligned skill development modules.

Duration

This MoU shall remain valid for a period of **three (03) years** from the date of signing. Upon completion of the tenure, the MoU **shall automatically renew for an additional period of three (03) years**, unless either party submits a written notice for non-renewal at least 30 days prior to

the expiry date.

Termination Clause

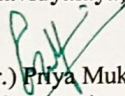
Either party may terminate this MoU by providing a written notice of 30 days, subject to mutual understanding.

- Any modification in this MoU will be made only with written approval from both sides.

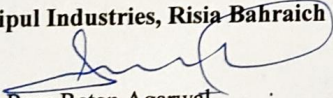

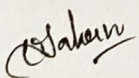
