MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (MoU) is executed on 19/10/2022, between **Mahila Mahavidyalaya, Bahraich** (Hereinafter referred to as "College") And **Chetna Clinic, Khatripura, Bahraich** (Hereinafter referred to as "Clinic"). Both parties agree to collaborate for promoting health awareness, medical support, and regular health-related services for students and staff of the College.

Purpose of the MoU

To establish mutual cooperation between the College and the Clinic for providing regular medical consultations, health check-ups, awareness programs, and emergency medical support.

Scope of Collaboration

Doctor Visits

- The Clinic shall ensure that a qualified doctor regularly visits Mahila Mahavidyalaya, Bahraich on predetermined days and timings.
- The frequency of visits shall be mutually decided and may be modified as required by the College's needs.

Health Services

- Basic health check-ups for students and staff.
- First-aid support and consultation during college hours.
- Health awareness sessions on topics such as nutrition, hygiene, mental health, women's health, etc.

Emergency Support

- The Clinic shall provide guidance for emergency medical cases and coordinate referrals as necessary.

Roles and Responsibilities

The College Shall:

- Provide necessary space and seating arrangements for health check-ups.
- Facilitate smooth coordination between Clinic staff and the College administration.
- Encourage students to participate in health programs.

The Clinic Shall:

- Provide timely and regular doctor visits as mutually scheduled.
- Maintain professional and ethical medical practices.

- Conduct awareness programs as per requirement of the College.

Financial Arrangements

- This MoU does not involve any financial liability for either party unless mutually discussed and agreed upon separately.
- If any special medical camp, training, or extended service is organized, applicable charges (if any) will be discussed and approved in advance.

Duration and Renewal

- This MoU shall remain in force for **five (5) years** from the date of signing.
- It shall be **automatically renewed** for the next term unless either party issues a written notice for modification or termination.

Termination Clause

Either party may terminate this MoU by providing a written notice 30 days in advance. Obligations already undertaken shall be fulfilled with mutual consent.

Dispute Resolution

Any dispute arising from this MoU will be resolved amicably through mutual discussion. If unresolved, it shall be referred to the competent legal authority in Bahraich jurisdiction.
