This Memorandum of Understanding (MoU) is entered into on 13/02/2024 between *Mahila Mahavidyalaya, Bahraich, Uttar Pradesh*, and *Government Degree College, Hasaur, Barabanki, Uttar Pradesh*, with the shared objective of fostering academic collaboration, promoting research excellence, and advancing innovation in higher education.

1. Purpose

The purpose of this MoU is to establish a formal framework of cooperation between the two institutions aimed at facilitating the exchange of knowledge, academic resources, and professional expertise. This collaboration seeks to enrich academic programs, enhance research outcomes, and contribute to the holistic development of faculty and students.

2. Scope of Collaboration

Both institutions agree to engage in mutually beneficial activities, maintaining the principles of equality, autonomy, and mutual respect. Areas of collaboration may include, but are not limited to, the following:

- Sharing of academic resources, research publications, and other relevant materials.
- Exchange of faculty members, researchers, and academic experts.
- Facilitation of student exchange programs, study tours, and educational visits.
- Joint participation in academic, research, and extension activities.
- Organization of national and international seminars, workshops, and conferences.
- Collaboration on research projects, publications, and scholarly initiatives.
- Undertaking any additional activities that contribute to strengthening academic cooperation between the institutions.

3. Implementation

Specific programs and activities under this MoU shall be developed and executed through mutual consultation. Each initiative will be governed by separate, jointly approved documents detailing implementation procedures, timelines, and financial responsibilities.

4. Duration and Renewal

This MoU shall remain in force for a period of five (5) years from the date of signing. It shall be automatically renewed for a subsequent term of five years unless either institution provides a written notice of intent to terminate the agreement at least six (6) months before the expiry date.

5. Designated Representatives

For effective coordination and successful implementation of this Memorandum of Understanding (MoU), both institutions hereby designate their respective Heads as official



representatives responsible for communication, coordination, and follow-up activities. The appointed representatives are as follows:

6. Financial Arrangements

Both parties mutually agree to utilize their existing infrastructure, facilities, and staff for the implementation of this collaborative programme. No additional financial liabilities shall be incurred by either institution, and the staff involved in this engagement shall not be entitled to any honorarium or additional remuneration.
