1. Preamble

This Memorandum of Understanding (MoU) is made and entered into on 18/07/2023, by and between Mahila P.G. College, Bahraich, a premier institution of higher education dedicated to women's empowerment through academic excellence, value-based education, and holistic development and Daylight Educational and Charitable Trust, Patna, Bihar, a registered charitable organization devoted to promoting education, supporting underprivileged students, and advancing the cause of social upliftment through educational initiatives.

Both institutions, acknowledging their shared commitment to promoting inclusive and equitable education, hereby agree to cooperate in the spirit of partnership and service to society.

2. Objectives of the MoU

1. To provide financial assistance and scholarships to deserving and economically disadvantaged students of Mahila P.G. College, Bahraich.
2. To ensure that no meritorious student discontinues education due to financial hardship.
3. To organize career guidance, counselling, and skill development programs for students.
4. To jointly promote educational awareness, digital literacy, and employability initiatives.
5. To encourage and mentor students in accessing national and institutional scholarship schemes and higher education opportunities.

3. Scope of Collaboration

1. **Scholarship and Financial Aid:**
Daylight Educational and Charitable Trust shall offer scholarships or financial assistance to eligible students, based on the recommendations of the college's Scholarship Committee and the Trust's selection guidelines.
2. **Awareness and Capacity Building:**
Both institutions shall jointly conduct workshops, seminars, and awareness programs on higher education opportunities, digital learning, and academic progression.
3. **Counselling and Mentorship:**
The Trust shall facilitate counselling and motivational sessions for students on education, personality development, and life skills.
4. **Verification and Documentation:**
The college shall verify the academic and financial credentials of applicants to ensure transparency and integrity in the selection process.
5. **Monitoring and Review:**
Both institutions will jointly review progress and outcomes of the collaboration annually to ensure effectiveness and sustainability.

4. Roles and Responsibilities

Mahila P.G. College, Bahraich shall:

- Identify and recommend eligible students for scholarships.
- Provide infrastructure and administrative support for collaborative programs.
- Facilitate student participation in all initiatives under this MoU.
- Maintain institutional records of beneficiaries and activities for reporting and accreditation purposes.

Daylight Educational and Charitable Trust shall:

- Provide financial assistance, counselling, and academic guidance to selected students.
- Conduct seminars, career counselling, and scholarship awareness sessions.
- Maintain transparency in selection and disbursement of funds.
- Share progress reports and outcomes with the college periodically.

5. Duration and Renewal

This Memorandum of Understanding shall remain in force for a period of five (5) years from the date of signing. Upon completion of this period, it shall automatically renew for successive terms of five (5) years each, unless either party provides written notice of intent to modify or terminate the agreement at least 60 days before the end of the current term.

6. Confidentiality

Both parties agree to maintain confidentiality regarding all student data, financial information, and institutional communications shared under this MoU, in accordance with applicable laws and institutional policies.

7. Termination

Either party may terminate this MoU by giving 60 days' written notice to the other party, provided that all ongoing commitments are duly fulfilled before termination.

8. General Provisions

- This MoU is based on mutual goodwill, cooperation, and shared goals.
- It does not create any financial or legal obligations beyond those explicitly stated herein.
- Both institutions shall retain their individual autonomy and identity in all collaborative activities.
