MEMORANDUM OF UNDERSTANDING (MoU)

Preamble

This Memorandum of Understanding (MoU) is executed on 02.04.2024, between **Mahila Mahavidyalaya, Bahraich**, an institution dedicated to the education and empowerment of women, and **Cyber Cell, Bahraich**, a specialized unit of the Police Department working to ensure online safety, prevent cybercrimes, and promote digital security awareness.

Both institutions recognize the increasing importance of cyber safety in the digital age and agree to collaborate to educate and empower students, particularly women, on responsible online behavior and cyber protection.

Objectives

The main objectives of this MoU are:

1. To spread awareness among students regarding **cyber safety, cyber laws, and responsible digital behavior**.
2. To organize **seminars, workshops, and training programs** on topics such as cybercrime prevention, online fraud, and data privacy.
3. To enhance **digital literacy** and understanding of safe social media practices among students.
4. To support victims of cyber harassment or online fraud through proper counseling and guidance.
5. To build a **secure and informed digital campus environment** through cooperation between the college and Cyber Cell.

Scope of Collaboration

Under this MoU, both parties agree to:

1. Conduct **joint awareness campaigns and training programs** related to cyber safety and digital rights.
2. Observe important days such as **Cyber Security Awareness Month** and **Safer Internet Day** through collaborative activities.
3. Facilitate **interactive sessions** with cyber experts and police officials for students and faculty.
4. Develop a **mechanism for reporting and addressing cyber harassment or online abuse cases** faced by students.
5. Share expertise, information, and resources for the successful implementation of cyber awareness initiatives.

Roles and Responsibilities

Mahila Mahavidyalaya, Bahraich

- To provide venue, facilities, and necessary support for all programs and activities conducted under this MoU.
- To encourage student participation in awareness and training sessions.
- To appoint a **faculty coordinator** to liaise with Cyber Cell, Bahraich, for smooth coordination.

Cyber Cell, Bahraich

- To provide expert speakers and officers for awareness programs, seminars, and workshops.
- To guide and support students in handling issues related to cyber safety, fraud, or harassment.
- To assist the college in creating educational materials and guidelines on digital security.

Financial Arrangements

Both parties agree to utilize their existing infrastructure, resources, and staff for the implementation of this collaboration. No additional financial obligations shall arise from this MoU.

Duration and Renewal

This MoU shall remain in force for a period of **five (5) years** from the date of signing and shall automatically renew for successive terms unless either party gives written notice for its termination or modification.

Amendment and Termination

This MoU may be amended or modified at any time by mutual written consent of both parties. Either party may terminate the MoU by giving **one month's written notice** to the other party.
