

Preamble

This Memorandum of Understanding (MoU) is executed on this 13.09.2022, between Mahila Mahavidyalaya, Bahraich, an educational institution committed to women's empowerment and holistic development, and Mahila Thana, Bahraich, a women's police station dedicated to ensuring the safety, security, and welfare of women in the district.

Both institutions, recognizing the importance of collaboration in promoting women's safety, legal awareness, and empowerment, agree to work jointly for mutual benefit.

Objectives

The main objectives of this MoU are:

1. To promote awareness on women's safety, legal rights, and self-defense among students.
2. To organize workshops, seminars, and training programs on gender sensitization, cyber safety, and prevention of crimes against women.
3. To encourage students' participation in community outreach programs related to women's welfare and protection.
4. To provide guidance and support to female students in addressing issues related to harassment, safety, and social challenges.
5. To develop a safe and supportive campus environment through joint initiatives.

Scope of Collaboration

Under this MoU, both parties agree to:

1. Conduct joint awareness campaigns and interactive sessions on topics related to women's safety and laws protecting women.
2. Facilitate self-defense training programs and safety awareness drives for girl students.
3. Observe important days such as International Women's Day, National Girl Child Day, and Women Safety Week with collaborative activities.
4. Share expertise, resources, and manpower for the successful implementation of programs.
5. Create a referral and support mechanism for students who may require counseling or police assistance.

Roles and Responsibilities

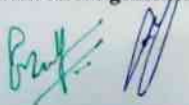
Mahila Mahavidyalaya, Bahraich

- To appoint a nodal faculty coordinator for communication and coordination with Mahila Thana.

Mahila Thana, Bahraich

- To provide resource persons, guidance, and police support for workshops and awareness sessions.
- To extend assistance in addressing safety-related concerns of girl students.
- To coordinate with college authorities for smooth execution of programs and initiatives.

Financial Arrangements



Both parties agree to utilize their existing infrastructure, resources, and staff for the implementation of this collaboration.
No additional financial obligations shall arise from this MoU.

Duration and Renewal

This MoU shall remain in force for a period of five (5) years from the date of signing and may be renewed automatically for successive periods unless either party gives written notice for its termination or revision.

Amendment and Termination

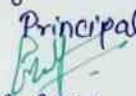
This MoU may be amended at any time by mutual written consent of both parties. Either party may terminate the MoU by giving one month's written notice to the other party.
