Preamble

Scope of Collaboration

Under this MoU, both parties agree to:

1. Responsibilities of Unnati Foundation:

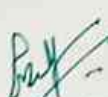
- Conduct the **UNXT Employability Training Program** free of cost for students.
- Provide trained and qualified facilitators to deliver the sessions.
- Cover modules including:
 - Spoken English
 - Effective Communication
 - Life Skills & Personality Grooming
 - Confidence Building

 - Public Speaking and Mock Interviews
- Provide necessary learning materials and certificates (if applicable).

2. Responsibilities of Mahila P.G. College:

- Facilitate necessary infrastructure including classrooms, audio-visual facilities, and logistics.
- Nominate a faculty coordinator to liaise with Unnati trainers.
- Encourage maximum student participation in the program.
- Provide administrative support for smooth execution of the training.

Program Structure

- **Duration:** 35–40 days (approximately 3 hours per day).

Financials

This MoU shall remain valid for a period of **five (5) years** from the date of signing and will be **renewed automatically** for subsequent periods of one year each, unless terminated by either party with one month's written notice.

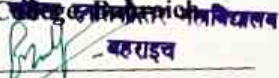
Confidentiality
