MEMORANDUM OF UNDERSTANDING (MoU)

And

Maharaja Suheldev Autonomous State Medical College, Bahraich

1. Preamble

This Memorandum of Understanding (MoU) is made and entered into on 13/12/2022 by and between **Maharaja Suheldev Autonomous State Medical College, Bahraich**, herein referred to as "**Medical College**", and **Mahila Mahavidyalaya, Bahraich**, herein referred to as "**College**", with a shared objective of promoting academic collaboration, community health awareness, and mutual institutional growth.

2. Purpose

The purpose of this MoU is to establish a framework for cooperation between the two institutions in the areas of:

- Health education and awareness among students and the local community.
- Organizing joint seminars, workshops, and outreach programs on health, hygiene, nutrition, mental wellness, and women's health issues.
- Conducting training programs and health camps for students and staff.
- Encouraging academic and practical exposure for students through collaborative activities.

3. Areas of Collaboration

Both institutions agree to collaborate in the following areas:

1. **Health and Hygiene Programs:** Joint initiatives on preventive healthcare, menstrual hygiene, nutrition, and lifestyle diseases.
2. **Workshops and Seminars:** Organizing guest lectures and awareness campaigns by medical professionals.
3. **Research and Extension Activities:** Facilitating student projects and surveys related to women's and community health.
4. **Health Camps:** Conducting free health check-up camps, blood donation drives, and mental health counseling sessions.
5. **Internship & Volunteering Opportunities:** Exploring avenues for students to engage in health-related social service under supervision.

4. Implementation

- Both institutions shall form a **Joint Coordination Committee** to plan and execute the collaborative activities.
- Each activity shall be mutually decided and organized as per convenience and institutional calendar.
- Both institutions agree to share their facilities, infrastructure, and expertise for the success of such programs.

5. Financial Arrangements

Both parties agree to utilize their existing infrastructure, resources, and staff for the implementation of this collaboration. No additional financial obligations shall arise from this MoU, and the staff involved shall not be entitled to any honorarium or additional remuneration.

However, if any specific **training program or workshop** involves external resource persons or materials, it shall be payable as per mutual consent.



6. Duration and Renewal

This MoU shall remain valid for a period of **five (5) years** from the date of signing and shall be **automatically renewed** for another term unless either party gives written notice of termination at least 30 days prior to the expiration.

7. General Terms

- Both institutions shall maintain transparency and mutual respect in all collaborative endeavors.
- Any amendment to this MoU shall be made in writing with the consent of both parties.
- This MoU does not create any legal obligation but expresses a mutual intent for cooperation.

8. Signatories
