This Memorandum of Understanding (MoU) is executed on 08/08/2024 between Mahila Mahavidyalaya, Bahraich (Hereinafter referred to as "The College") and Zainab Education Welfare Society (Hereinafter referred to as "The Society").

Purpose of the MoU

The purpose of this MoU is to establish academic, training, research, social outreach, skill development, internship, and community welfare collaboration between Mahila Mahavidyalaya, Bahraich and Zainab Education Welfare Society to enhance learning, exposure, and community support services for students.

Areas of Collaboration

Both institutions agree to work collaboratively in the following areas:

1. Internships and Practical Exposure for students in social work, community service, skill development and related fields.
2. Workshops, Seminars, Guest Lectures, Awareness Programs on themes such as women empowerment, health, literacy, entrepreneurship, legal awareness, and social welfare.
3. Skill Development Programs including vocational training, digital literacy, career guidance, and personality development.
4. Community Outreach Activities targeting women, children, and economically weaker sections.
5. Research and Documentation Support for social welfare projects.
6. Student Volunteering and Participation in NGO initiatives.
7. Any additional collaboration agreed mutually in writing.

Roles and Responsibilities

Mahila Mahavidyalaya, Bahraich Shall:

- Nominate faculty/ coordinators for smooth execution of activities.
- Encourage student participation in activities under this MoU.
- Provide academic and institutional support wherever required.

Zainab Education Welfare Society Shall:

- Provide internship and field work opportunities to students.
- Arrange expert speakers, trainers and resource persons.
- Facilitate social welfare activities and training modules.

Financial Terms

Both parties agree that this MoU is non-financial in nature. Any activity requiring funding will be discussed and approved separately in writing.



Duration and Renewal

This MoU will remain effective for a period of five (05) Years from the date of signing. It shall be automatically renewed for the next term unless either party submits a written request for termination with a 30-day prior notice.

Confidentiality

Both institutions agree to maintain the confidentiality of data, records, reports, and any shared information under this MoU.

Termination

Either party may terminate this MoU with 30 days written notice to the other party without affecting ongoing activities.

Legal Clause

This MoU is based on mutual understanding and does not create any legal or financial liability for either institution.

This MoU is signed in duplicate, with each party retaining one original copy.

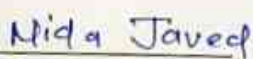

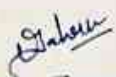
