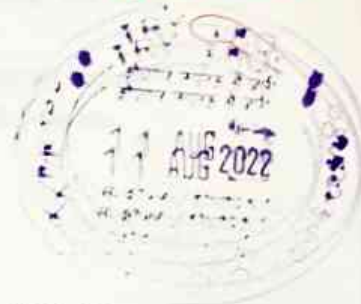

MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (MoU) is executed on 16/10/2024, between **Mahila Mahavidyalaya, Bahraich, Uttar Pradesh** (Hereinafter referred to as "*Institution/College*") and **Natraj Sangeet evam Chitrakala Prashikshan Kendra, Bahraich, Uttar Pradesh** (Hereinafter referred to as "*Academy/Training Partner*").

Purpose of MoU

The purpose of this MoU is to establish academic cooperation and skill development opportunities in the field of Music (Vocal/Instrumental), Drawing, Fine Arts, Painting, and Performing Arts for the students of Mahila Mahavidyalaya, Bahraich.

Objectives

1. To conduct certificate/diploma training programmes in Music and Fine Arts.
2. To provide practical exposure, workshops, masterclasses, and training in performing and visual arts.
3. To promote cultural activities, art exhibitions, stage performances, and talent development.
4. To support the academic and skill development of students through expert-led sessions.
5. To enhance employability and entrepreneurial skills in creative and performing arts.

Roles and Responsibilities

Mahila Mahavidyalaya, Bahraich Shall:

- Select and enroll interested students for training programmes.
- Provide classrooms/halls or infrastructure when necessary.
- Assist in coordination, communication, and certification processes.

Natraj Sangeet evam Chitrakala Prashikshan Kendra Shall:

- Provide trained instructors in Music, Drawing, Painting and Performing Arts.
- Conduct regular classes, training sessions, workshops, and assessments.
- Assist in organizing cultural events, exhibitions and certification exams.
- Provide professional exposure and guidance to students.

Financial Terms

Fee structure, resource charges, and operational regulations shall be mutually discussed and finalized through a separate written agreement before commencement of activities.

Duration and Renewal

This MoU shall remain valid for **three (03) years** from the date of signing.



It will be **automatically renewed** for the next term unless either party submits a written termination notice **30 days** prior to the expiry.

Termination Clause

Either party may terminate this MoU through a written notice of **30 days**, provided all ongoing activities are completed responsibly.

Dispute Resolution

Any disputes arising under this MoU shall be resolved amicably and mutually through discussion between both parties.

Legal Status

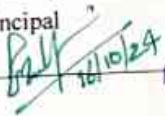
This MoU is not legally binding and is intended only for academic collaboration, cooperation, and mutual benefit.

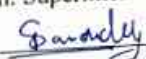

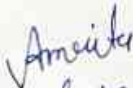
